One Part-Time Temporary up to 12 month contract position, 0.6 FTE (21 hours/week)

Position Overview:

The Community Health Worker (CHW) will play a key role in supporting the implementation of the Nail Salon Workers' Project (NSWP), with a focus on engaging Black and Latin American nail technicians (NTs). Funded by the Metcalf Foundation, this phase builds on ongoing work by the NSWP, a program of Parkdale Queen West Community Health Centre, which seeks to reduce the health risks faced by those working in discount nail salons and to promote safer, more equitable working conditions. The NSWP focuses on training and capacity building, research, policy advocacy, partnership development, and community-led program design. This role will help deliver culturally relevant health promotion, outreach, and rights-based education tailored to the experiences of nail technicians in the sector.

The CHW will work closely with peer outreach workers, partner agencies, and community members to improve occupational health and labour conditions for NTs through direct engagement, training delivery, and resource development. This role is rooted in a community development approach and requires strong relationship-building skills, cultural competency, and a commitment to social justice.

Reporting Manager: Manager, Health Promotion and is based out of the Dundas Site.

Key Responsibilities:

1. Community Engagement & Outreach

- Conduct outreach to discount nail salons and other locations where nail services are provided to build relationships and engage Black and Latin American NTs.
- Deliver mini workshops on occupational health, and safe workplace practices using established educational materials.
- Distribute culturally appropriate educational resources and personal protective equipment.
- Support the recruitment of peer outreach workers and coordinate their ongoing activities and schedules.
- Contribute to ongoing program planning and development in collaboration with the team.

2. Health Promotion & Education

- Support the development and delivery of peer-led workshops focused on occupational health and safety (OHS).
- Tailor messaging and resource materials to reflect the needs and lived experiences of Black and Latin American NTs.
- Gather feedback from NTs to inform ongoing project improvement and culturally responsive programming.

- Understanding of peer programming and experience working with peers
- Facilitation, program development and evaluation skills
- Excellent verbal and written communication abilities
- Proficiency in the use of computers and excellent organizational skills
