Nurse Practitioner – Refugee Health

General Responsibilities: We are currently seeking one Nurse Practitioner (NP) to work in our Primary Care team, with the specific focus of delivering culturally relevant care to refugees and asylum seekers. The NP will also facilitate perinatal clinics, including pre-natal and post-partum care, well-baby visits, immunizations, as well as educational sessions. Our clinical team works closely with our mental health, harm reduction and health promotion teams to ensure cross-team and cross-site collaboration. The NP will work with members from those teams in providing mobile service off-site in partnership with other community partners and via the Mobile Health Clinic, as well as in program development and implementation.

Specific Responsibilities:

- The NP, Refugee Health provides holistic health care to clients of all ages and performs clinical tasks, including history taking; ordering routine diagnostic tests; making diagnoses and plans of care
- Provides brief counselling and support to clients to manage their mental health concerns, substance use needs or other difficulties and makes referrals to internal or external programs and services.
- Identifies trends or issues related to the health status of priority groups and uses this information in planning and advocacy work.
- Establishes clinics at partnering agencies in conjunction with other clinical and non-clinical staff.
- Performs routine outreach with internal Centre programs/leads as appropriate.
- Provides primary care as a member of an interprofessional team, including physicians, nurses, physiotherapists, dieticians, counsellors, etc., and refers clients to appropriate wraparound services
- Maintains timely, high-quality documentation in client/patient files through PQWCHC's EMR to meet the requirements of the funders, the Centre, and regulatory bodies (i.e., College of Nurses of Ontario).
- Participates in the design, implementation, and evaluation of research studies in consultation with the Management team and other staff.
- Participates in evaluation, communities of practice, presentations, and academic requests for information sharing.

Qualifications:

- RN (EC) training from a recognized program
- Current registration as a Registered Nurse (EC) with the College of Nurses of Ontario (CNO)
- Experience in a community setting or combination of community, hospital, or public health settings.
- Understanding of the socio-cultural and psychological challenges faced by refugees and asylum seekers and demonstrated ability to incorporate this knowledge into delivering culturally relevant care; knowledge through lived experience considered an asset.
- Demonstrated ability to de-escalate conflict an asset.
- Confidence in asserting and maintaining strong boundaries.
- Knowledge of community services and resources; strong advocacy skills.
- Proficiency in the use of electronic medical records.
- Strong oral and written communication skills.
- Respects and values the diversity of communities and individuals.

Work environment and physical/mental/cognitive requirements:

- Work is conducted in community health centre environments as well as during visits to partner locations
- Ability to travel throughout the day is required
- Ability to focus in environments with occasional loud noises and other sensory stimulation
- Ability to balance all job requirements in a busy atmosphere, including responding promptly to all communication
- Frequent standing for extended periods of time and occasional lifting may be required
- Ability to regulate emotions and maintain professional boundaries
- Frequent data entry, with extended periods of time sitting or standing stationary in front of a monitor while keyboarding
