### **Overdose Prevention Support Worker - Supervised Consumption Services**

**One (1) Weekend Part-Time Regular Position at 0.4 FTE (14 hours/Weekend), Bargaining Unit – UFCW – Local 175**

**Parkdale Queen West Community Health Centre** (Parkdale Queen West CHC) is a dynamic, community-based health care organization serving mid-west downtown Toronto. Offering a broad range of services, including primary health care, dental care, harm reduction, health promotion, counselling, and community development programming, we are also committed to serving people who face barriers to health care, and we strive to reduce these barriers. PQWCHC is a multi-sited organization.

We are seeking an experienced Overdose Prevention Support Worker (weekends) who shares our passion for making a difference; you see this role as an opportunity to take the next step in your successful career while contributing to a vision of ***Inclusive Communities. Responsive Healthcare. Healthier Lives.***

Striving for excellence in client-centred care and education, you will work as part of the multidisciplinary, integrated Supervised Consumption Services (SCS) team, within a harm reduction framework, and in alignment with the vision and values of PQWCHC. In so doing, you will help ensure that SCS operations comply with all exemption requirements and guidelines, as well as PQWCHC policies and procedures. In the role of SCS Overdose Prevention Support Worker, you will provide education and support on safer injection and consumption, monitor clients for adverse reactions, assess, respond to, and support overdose events, and assist in the initiation of emergency responses, as necessary. You will also assist in client de-escalation and provide support for crowd control and make referrals to other health and social service providers.

*You have at least 1 year of experience working in a harm reduction program and/or a community setting, working with homeless and marginalized populations, including people who inject illicit drugs. You have experience with overdose prevention and response and training in/experience with Naloxone administration. Confident in asserting and maintaining strong boundaries, you bring substantial knowledge of drug use, specifically injection drug use, acquired through a combination of work experience, lived experience and/or education or training, are familiar with community services and resources, and respect and value the diversity of communities and individuals.*

Proficiency in one or more languages other than English would be an asset, as would experience in the following areas: working in a supervised consumption or overdose prevention service; providing overdose training, including Naloxone administration; and working with people who use drugs, racialized populations, Indigenous peoples, people who engage in sex work, prisoners/ex-prisoners, people with mental health challenges, and people who have experienced trauma.

You will be required to work at both of our sites (Queen West site: 168 Bathurst Street, or our Parkdale site: 1229 Queen Street West).

Hours are: You will be expected to be on-site for 8 hours on Saturday and 8 hours on Sunday, but both days will be 7 hours worked with a 1-hour unpaid lunch.

**Compensation:** \$50,561 to \$59,538 per annum plus HOOPP (Healthcare of Ontario Pension Plan)

Note: Salary will be prorated to a 0.4 FTE.
